The Community Foundation of the Brazos Valley, headquartered in Bryan – Texas, administers a charitable endowment fund that was established in memory of Leo L. Livingston by Doris Livingston to benefit nonprofit organizations in the Taylor, Texas community. A local Grants Review Committee comprised of Taylor residents and business leaders is accepting applications from nonprofit organizations for **grants up to \$10,000 for programs that support the Livingston's goals of continually improving the quality of life in Taylor, Texas.** Qualifying nonprofit organizations must have I.R.S. 501(c)(3) tax-exempt status.

The Grants Review Committee will consider grants to:

- Support effective, established programs;
- Help launch innovative, new programs; or
- Fund unique capital needs that will increase an organization's capacity.

Grants will not be made to underwrite or sponsor fundraising events or public relations events. Livingston Fund grants can be used to provide salary support.

**Grant applications must be received via e-mail or postmarked by **FRIDAY, MARCH 8**; grant recipients will be notified no later than Friday, April 12.**

To apply for a Livingston Grant, please provide the information requested below. Only one application per organization will be considered. Incomplete applications or applications missing required information will not be considered for funding.
